Upon acceptance of your application and dues you agree fully to the terms and conditions listed below and the rules/by-laws of the ISSA. **This form must be completed in full and signed.**

- **Ordinary Membership: \$50**
 - Ordinary members in good standing (defined in the constitution clause 2), may enter and or helm a boat at Swift Solo fleet events and race in regional or international championships or other ISSA sanctioned regattas (subject to the class rules and entry requirements in the NOR or SI). Ordinary members are entitled to hold executive office and to vote on ISSA issues.
- **Associate Membership: \$25**
 - A friend of the Swift Solo Class can join the ISSA as an associate member. Associate members may have access to class, building and construction information such as rigging manuals etc. that are not available to the public. Associate members do not vote on class matters and are not entitled to helm a boat at ISSA sanctioned events.

Note: Purchase of the Swift Solo construction plans and manual from the designer automatically entitles access to all available building resources (and currently telephone help from the designer) and full membership of the ISSA free, for one year from time of purchase of plans.
